






Author Process: Acceptance and Copyright



Acceptance

- If the manuscript is accepted, the author will be prompted to upload the final files and choose a copyright license.
- Hybrid journal authors will choose to publish open access or traditional (closed).

Once they submitted final files, the author is met with a screen that gives them a prompt to click and sign off on the Publishing Agreement.





Post acceptance – copyright selection

After acceptance, authors will be prompted to choose a copyright license using the IEEE Electronic Copyright Form (eCF).

- Authors publishing in hybrid journals may choose between:
 - **CC-BY**: author retains copyright and the article is published open access
 - CC-BY NC-ND: author retains copyright in a more restrictive license than CC-BY in that the article may not be reused for commercial purposes, nor may the article be changed in any way
 - **Traditional** license in which copyright is transferred to the publisher and the article is published behind a paywall
- Authors publishing in gold journals may choose between **CC-BY** or **CC-BY NC-ND**.
- Authors should confirm any license restrictions set by the institution.

Author Process: RightsLink for Scientific Communications (RLSC)



RightsLink for Scientific Communications (RLSC)

- All article processing charges (APCs) are handled through CCC RLSC on behalf of IEEE.
- After acceptance, authors receive an email prompting them to pay all charges through RLSC.
 - In a touch-free workflow, RLSC will generate a funding request automatically when a manuscript matches an institutional profile.
- If the author is affiliated with an institution that has an OA agreement, they will be prompted to seek funding from their institution.
- Institutional profiles are matched using author-provided affiliation data including email domains and/or Ringgold IDs. Wild cards can also be used when matching on email domain.



Article Acceptance

A funding request is automatically sent to the institution when a manuscript matches the touch free profile.

The author receives an email when the request is approved or denied by the institution.

Be sure to use your institutional email, which will be used as a secondary option to match your manuscript to an open access agreement.

If your article is accepted and you publish your article as open access, you will receive an email notification regarding APC/open access payment processes to submit a funding request. (Note: In some agreements, an open access administrator may receive this funding request automatically and you would not receive an email notification.)

Once the request is submitted, your institution's OA administrator will receive and review for approval.

To ensure accurate processing, please be sure to use your institution's name from the dropdown menu as well as your own institutional email address for all forms and submissions.
